When booking to PC SO Frostin Royal mare owners have THREE options:

#1: Haul the mare to The Kansas Center For Equine Reproduction located in Lawrence, KS. Our vet [Shelby Hayden] at this facility will be able to breed the mare on site with cooled fresh semen. If the mare owner chooses this option, they will not need to pay shipping fees. Mare owner will still be responsible for the cost of collection and processing of semen. The associated cost would be paid by mare owner directly to The Kansas Center For Equine Reproduction (KsCER). Please contact KsCER directly to make an appointment for your mare (785) 813-5922. [Kansas Center For Equine Reproduction – 760 N 950th Road, Lawrence, KS 66047]

Please keep in mind if you plan to haul your mare to KsCER they typically book a month out. Call to get your mare on the books early! (785)813-5922. You must make an appointment, do NOT just show up.

#2: Mare owner can personally pick the semen up from KsCER in Lawrence, KS and personally transport to vet of choice, mare owner must still pay cost of collection and processing of the semen. Please call KsCER for exact cost if needed (785)813-5922. Always call to schedule a pickup! Estimated cost of \$250-300, please call KsCER to confirm current fees.

#3: Have the semen shipped to the vet of choice by mare owner. If the mare owner chooses to ship semen it is \$500 for the first shipment and each additional shipment will be \$500. The shipment and stud fee MUST be paid in full before we will ship any semen. No exceptions. We ship on every Monday, Wednesday, and Friday except for Memorial Day AND any FedEx Holidays. Frozen semen can be shipped at any time and is \$600 per shipment.

To order shipped semen please text or call Michelle Hamilton at (660-898-8510). We do require a 24-hour notice. We try to be flexible and might be able to get a shipment last min. but it is not guaranteed without a 24-hour notice. DO NOT CONTACT KSCER. If mare owner or vet is requesting a shipment you must contact Michelle Hamilton directly. Texting is preferred! Please note that our breeding season for fresh semen shipments will be March 1ST – July 1st in 2026. If needing semen before or after we will have frozen available.

Payment Options: Mare owner can pay using Venmo, Check, OR Email Invoice. If paying by check, check will need to be cleared before semen is shipped, so plan accordingly. If you need an email invoice, please text Michelle to request an invoice at 660-898-8510. Please mail all checks to Michelle Hamilton at the address listed at the top of the contract. All checks need to be made out to Michelle Hamilton. Venmo can be sent to [Miss-Hamilton]

Important Notes: We do NOT offer counter to counter shipments. If your mare is not in foal by July 1st you will have to use frozen semen. Frozen semen shipments cost \$600 per shipment. No fresh semen shipments after July 1st, 2026.

Once the mare is confirmed in foal, please report breeding dates and confirm with Michelle Hamilton that all mare information is correct for the breeding report. It is the mare owner's responsibility to confirm this information to make sure it is correct. If not done this could result in the foal not being able to be registered. Please double check to make sure all information on the contact is 100% accurate.
